While gifts such as wine or champagne are generally not tax-deductible, they can still be provided as part of a **staff annual event**, such as a Christmas party, where the cost is within HMRC's allowance of **£150 per head**. For client gifts, alcohol can be included if it's part of a larger branded hamper, but it will not be deductible.



## Additional Tips for Corporate Gifting

1. **Avoid Personal Gifts:** Gifts that appear overly personal or unrelated to business (e.g., jewellery) will not qualify as tax-deductible.
2. **Consider VAT:** If the gift meets tax-deductibility criteria, you can usually reclaim the VAT.

3. **Document Everything:** Keep detailed receipts and records of who received each gift to ensure compliance with HMRC regulations.
